

DOCUMENT 00 11 14 - NOTICE TO BIDDERS

The **RICHLAND - LEXINGTON AIRPORT DISTRICT (RLAD)** will receive sealed proposals for the **2019 Inbound BHS Improvements** project, at the Columbia Metropolitan Airport Terminal Building, CAE Administrative Office (East Ticketing), 3250 Airport Boulevard, Suite 10, West Columbia, SC, 29170, Attn: Mr. Frank Murray, Director of Planning & Facilities until **2 p.m. EDT on Tuesday, May 21, 2019**, at which time and place bids will be publicly opened and read aloud. An official clock will be established in the above location. Bids received after stated time will not be accepted.

PREBID CONFERENCE

A Mandatory Prebid Conference will be conducted in the Carolina Room in the Columbia Metropolitan Airport Terminal Building, 3250 Airport Boulevard, West Columbia, South Carolina, 29170 at 1:00 p.m. EDT, Tuesday, May 7, 2019. The Carolina Room is located adjacent to Baggage Claim on the Lower Level of the Terminal. Parking is available in the Terminal Parking Garage and validation will be provided. Bidders are required to attend in order to submit bids on the project. A tour of the project site will be conducted after this Conference. Requests for site visits at times other than the Prebid Conference are subject to availability of airport personnel for access and escort. Questions about the meaning or intent of the project shall be addressed to the Office of the Architect/Engineer and be made in writing.

SCOPE OF WORK

The overall scope of this project includes the complete refurbishment of the inbound baggage handling system including conveyors, controls, baggage claim devices and associated components and systems. Temporary facilities will also be required to maintain the terminal operations.

The system refurbishment will be made while the terminal is in full operation; this will require the work to be scheduled to ensure that portions of the inbound baggage handling system are always operational. This project will be phased, and a phasing plan has been included on the drawings.

PROJECT FUNDING

This project is funded under provisions of the Airport and Airway Safety and Capacity Act of 1987. The award of this contract is contingent upon the availability of Federal funding. Certain mandatory Federal requirements apply to this solicitation and will be made a part of any contract awarded including, without limitation:

- (a) President's Executive Order No. 11246 as amended by 29 CFR Part 30 and 41 CFR Part 60;
- (b) Davis-Bacon and Related Acts, 29 CFR Parts 1, 3 and 5;
- (c) Affirmative Action to Ensure Equal Employment Opportunity (Executive Order 11246 and DOL Regulation 41 CFR Part 60);
- (d) Copeland Act, 29 CFR Part 3;
- (e) Contract Work Hours and Safety Standards Act;
- (f) Title VI of Civil Rights Act of 1964;
- (g) Government-Wide Debarment and Suspension and Government-Wide Requirements for Drug-Free Workplace (DOT Regulation 49 CFR Part 29);
- (h) Buy American Preferences (Title 49 United States Code, Chapter 501);
- (i) Foreign Trade Restriction: Denial of Public Works Contracts to Suppliers for Goods and Services of Countries that Deny Contracts to Suppliers of Goods and Services of Countries that Deny Procurement Market Access to U.S. Contractors (DOT Regulation 49 CFR Part 30);
- (j) Goals for Minority and Female Participation (41 CFR Part 60-4.2);
- (k) Certification of nonsegregated Facilities (41 CFR Part 60-1.8);
- (l) Debarment, Suspension, Ineligibility and Voluntary Exclusion (49 CFR Part 29);
- (m) Bid guarantee of 5% (49 CFR Part 18.36(h)(1));
- (n) Performance Bond of 100% (49 CFR Part 18.36(h)(2));
- (o) Payment Bond of 100% (49 CFR Part 18.36(h)(3)); and

(p) Disadvantaged Business Enterprises (DBE) participation 49 CFR Part 26 will be required as described in Subpart D of Regulation 49 CFR Part 26, and all pertinent amendments. It is the policy of the Richland - Lexington Airport District to practice nondiscrimination based on race, color, sex, or national origin in the award or performance of this contract. All firms qualifying under this solicitation are encouraged to submit bids/proposals. Award of this contract will be conditioned upon satisfying the requirements of this bid specification. These requirements apply to all bidders, including those who qualify as a Disadvantaged Business Enterprise.

The Owner has established a DBE contract goal of 2.0% for this contract. The Bidder shall make good faith efforts, as defined in Appendix A, 49 CFR Part 26, to subcontract 2.0% of the base bid dollar value of the prime contract to certified DBE firms as defined in 49 CFR Part 26. All bidders shall submit the following information with their proposal on the forms provided:

- (1) The names and addresses of DBE firms that will participate in the contract;
- (2) A description of the work that each DBE firm will perform;
- (3) The dollar amount of the participation of each DBE firm participating;
- (4) Written documentation (Schedule of DBE Participation) of the Bidder/Offeror's commitment to use a DBE subcontractor whose participation it submits to meet the contract goal; and
- (5) Where the stated DBE Goal is not met, evidence of good faith efforts undertaken by the bidder, as described in Appendix A to 49 CFR Part 26.

The apparent successful Bidder will be required to provide written confirmation from the participating DBE firms verifying their intent to participate in the project. This written confirmation shall be submitted as a condition of bid responsiveness.

By submitting a bid under this solicitation, except for those items listed by the Bidder in a clearly identified attachment to the Bid, the Bidder certifies that steel and each manufactured product, is produced in the United States (as defined in the clause Buy American - Steel and Manufactured Products for Construction Contracts) and that components of unknown origin are considered to have been produced or manufactured outside the United States.

Each Bid shall be accompanied by bid security in the form of a Bid Bond, cashier's check, or certified check made payable to Richland - Lexington Airport District, equal to 5% of the total bid. Contract Security in the form of 100% Performance and Payment Bonds will be required of the successful bidder. All bonds shall be from a surety company authorized to transact business in the State of South Carolina.

No bid may be withdrawn after closing time for the receipt of bids for a period of ninety (90) days. All bids shall be submitted on the Bid Form supplied with the Bid Documents. All forms and requirements listed in the Bid Form shall be responded to in a complete manner. Failure to do so may result in the rejection of the Bid.

Bidders are required to be properly licensed in the State of South Carolina at the time of submission of the Bid. The Bidder shall supply its South Carolina Contractor's License Number on the Bid Form and on the outside of the sealed envelope containing the Bid. Additional requirements for bid submission are specified in the Instructions to Bidders.

The Richland - Lexington Airport District reserves the right to waive any informalities or irregularities in or to reject any or all Bids and to award or refrain from awarding the Contract for the work, whichever is deemed to be in the Authority's best interest.

The Richland - Lexington Airport District
